PLAINTIFF-APPELLEE'S SPECIAL MOTION TO DISMISS APPLICATION FOR LEAVE TO APPEAL

The People of the State of Michigan, by Molly Schikora, Assistant Prosecuting Attorney, move to dismiss Defendant-Appellant's Application for Leave to Appeal pursuant to MCR 7.110 and 7.211(C)(2)(b) and state as follows in support of their special motion to dismiss:

- 1. Defendant-Appellant is charged with one count of Trespass, contrary to MCL 750.552.
- 2. On February 4, 2021, the trial court heard and denied Defendant's motion for summary disposition. An order was signed dismissing the motion on February 5, 2021. Defendant filed an interlocutory application for leave to appeal to this Court untimely and the application for leave to appeal was denied sua sponte.
- 3. On April 7, 2021, Defendant-Appellant filed a second untimely appeal related to the February 4 hearing as well as to events that occurred prior to February 4. Meanwhile, she has

since filed an application for leave to appeal in the Court of the Appeals as to the issues first

raised on application to this Court.

4. Her current untimely pleading exceeds the 50 page limit set forth under MCR

7.212(B). This offense is exacerbated by her piecemeal approach to pursing appellate remedies.

WHEREFORE, the People-Appellee, respectfully request that this court dismiss

Defendant-Appellant's nonconforming application for leave to appeal.
